## **History**

The Sierra Club, the United States' oldest and largest environmental organization, was founded by John Muir on May 28, 1892. Since its establishment, the organization has been devoted to studying and protecting national scenic resources, demonstrating a particular interest in the conservation of mountain regions. Its specific purpose is:

To explore, enjoy, and protect the wild places of the earth; to practice and promote the responsible use of the earth's ecosystems and resources; to educate and enlist humanity to protect and restore the quality of the natural and human environment; and to use all lawful means to carry out these objectives. Although the Sierra Club has taken a global interest in the environment, it primarily concentrates on regions within the United States.

The Tehipite Chapter of the Sierra Club was established to accomplish the Sierra Club's mission within its boundaries, which includes all of Fresno, Madera, Mariposa, and Merced Counties as well as segments of Tulare and Tuolumne Counties. The chapter has an executive committee and several committees such as Awards, Membership and Outings. There is also an affiliate group in Merced with its own officers and activities. The Tehipite Chapter focuses its conservation efforts on this region, with a particular interest in Yosemite and Kings Canyon National Parks, but is also involved in statewide, national and global issues. The chapter holds monthly meetings and hosts an annual banquet, in addition to offering several hikes and other outdoor outings each month, which are open to the public.

### **Scope and Content Note**

The Tehipite Chapter of the Sierra Club records measure 11 linear inches and date from 1979 to 2002. The collection is arranged in eight series: Correspondence, Financial, Meetings, Membership, Organization, Political issues, Publications, and Photographs.

The **Correspondence** series (1987-1993, 1997-2000 and undated) consists primarily of letters from former chairmen of the Tehipite Chapter. The correspondence covers a variety of topics, including club outings, legal proceedings and environmental programs. There is also a short mailing list.

The **Financial** series (1985-1991, 1996-2000 and undated) consists of detailed information regarding the Tehipite Chapter's financial accounts. This includes balance sheets, income/expense registers, cash flow reports and account statements. There are also more general budgetary items, specifically, proposed budgets and treasurer's reports. In addition, there are

copies of financial contracts between the Tehipite Chapter and the Unitarian Universalist Church for the use of church facilities for chapter events.

The **Meetings** series (1985-1992, 1994-2000 and undated) contains information regarding meetings held by the Tehipite Chapter as well as those conducted by the chapter's Executive Committee.

The <u>Chapter</u> subseries contains annual calendars that list, by month and day, all meetings for the chapter. This includes listings of Sierra Club conventions, general chapter meetings and meetings of chapter committees. These schedules also provide information regarding special events, including banquets and outings. The subseries also contains minutes of general chapter meetings.

The Executive Committee subseries primarily consists of agendas and minutes of Executive Committee meetings. Many of the documents are in both rough draft and final draft form. In addition, the subseries contains two resolution requests proposed by the Tehipite Chapter's Conservation Committee for consideration by the Executive Committee. Both resolutions ask the Executive Committee to oppose potential legislation. One involves an antiwater meter initiative in Fresno and the other involves the proposed construction of a toxic waste incinerator at Kettle Hills.

The **Membership** series (1983, 1986-1991 and undated) contains information regarding membership in the Tehipite Chapter and its committees. This includes chapter activity reports, which tabulate and list the total membership in the chapter, and chapter change reports, which list individual members by name. The series also contains committee membership registers, which list those serving in committee positions.

The **Organization** series (1982, 1986, 1988-1990, 1992-2000 and undated) contains information helpful to understanding the Tehipite Chapter as well as the Sierra Club as a whole. There are bylaws, directories, information regarding leadership responsibilities and member resources. The elections section of the series details elections held within the Tehipite Chapter. This consists of ballots, candidate statements and documents related to the Tehipite Chapter Nominating Committee, including correspondence with candidates, polling outcomes and procedural guidelines. There is also fundraising information, including general requirements and specific information regarding banquets held by the Tehipite Chapter. Also within this series is a data sheet, which compiles detailed information regarding the Sierra Club and its chapters, including leadership, governance and activities.

The **Political issues** series (1979-1980, 1986-1992, 1997-2000, 2007-2009 and undated) consists of information regarding the political involvement of the Tehipite Chapter. The series contains

information, including correspondence, pamphlets and policy statements, regarding the Sierra Club's interest in political issues. Most of the topics involve environmental legislation. This includes information about air and water quality, deserts, forestry, wetlands, wildlife and the Yosemite National Forest. Other topics include education, transportation and urban development.

The **Publications** series (1980-1981, 1984, 1987, 1990, 1992, 1998, 2002 and undated) contains newspaper clippings, flyers, notices and copies of *Tehipite Topics*. The clippings are from the *Fresno Bee* and contain information on both the Tehipite Chapter and the Sierra Club. The flyers give information on Sierra Club activities and interests. The Sierra Club and its Tehipite Chapter distributed the notices, many of which ask for donations or inform members on events and policies. *Tehipite Topics* is a publication issued by the Tehipite Chapter that addresses the club's political involvement and activities.

The **Photographs** series (undated) contains photographs of members of the Tehipite Chapter as they take part in club events, including outings, dinner and political presentations. Some specific events included the Save the Kings River Canyon picnic and an outing to the Cottonwood Pack Station.

### Mineral King Collection

This collection contains information on the Sierra Club's involvement in an attempt to stop development of a road through the Mineral King Valley. There are Sierra Club bulletins, correspondence, legal documents and newsletters, including copies of *Tehipite Topics*. See Box 3, Sierra Club, 1961-1996.
