Biographical / Historical

George Nicholas Zenovich was born on April 29, 1922 in Fresno, CA to parents Nicholas and Eva who had immigrated to the United States from the former Yugoslavia. He attended high school and college in Fresno. Zenovich was elected student body president at both levels of education. He graduated from Fresno State College with a Political Science degree and earned his law degree from Southwestern College of Law. Zenovich joined the military during World War II. He was enlisted for three years as an Army Air Force Japanese Code Interceptor Operator and then later was part of the Air Force Band playing the stand-up bass. He began practicing law as an attorney in 1953.

In 1956, he was elected to the Fresno County Democratic Central Committee. An early supporter of John F. Kennedy, he became Chairman of the Fresno County Democratic Committee for President John F. Kennedy.

He was then elected to the California State Assembly as an Assemblyman for the 32nd District and served from 1963 to 1970. During his Assembly tenure, Mr. Zenovich served as Majority Floor Leader and Chairman of the Democratic Caucus under Speaker Jesse Unruh. He also became known as a strong advocate for farming communities in the San Joaquin Valley.

In 1970 he was elected to the State Senate, representing the 16th District. During his eight years as a State Senator, he was instrumental in the passing of three highly influential pieces of legislation. The first was the creation of the California Housing Finance Agency, which provided low-interest housing loans for low income families. The second was the California Agricultural Labor Relations Act: the first law in the nation to establish secret ballots and a machinery for settling farm labor disputes. The third law established the California Arts Council.

Zenovich was appointed by Governor Jerry Brown to be Justice of the 5th District Court of Appeals in 1979. He held that position until he retired in 1984. His interest in politics did not waiver after he left the bench as he continued to be involved in Sacramento as a lobbyist.

Zenovich played the stand-up bass throughout his career. In 1955 he married Vera Sarenac. He had two children, Ninon and Marina and two grandchildren, Nicole and Theo. He passed away in September of 2013 in Fresno.

The new Courthouse for the Fifth Appellate District of the California Court of Appeals is named after him.

Scope and Contents

The George N. Zenovich papers measure 7.5 linear feet and date from 1955 to 1994. The collection is arranged in eight series: Campaign, Judicial, Legislative work, Newspaper clippings and articles, Personal, Press releases, Multimedia, Photographs, and Artifacts.

The **Campaign** series (1962-1978) is made up of papers from both campaigns as an Assemblyman and Senator. This includes correspondence that congratulate Zenovich in his successes, a poster, and various campaign materials. There are also miscellaneous papers that list contributors to his campaigns.

The **Judicial** series (1978-1993) contains newspaper clippings that range from his appointment to the 5th District Court of Appeal to decisions made during Zenovich's career as a justice. It also includes a sample ballot, a resolution, programs, and correspondence that took place during his years as a Justice.

The **Legislative work** series (1962-1995) covers Zenovich's career as Assemblyman and Senator. It is mostly made up of various correspondence. The correspondences are between Zenovich and his colleagues or concerned people involved in politics. The series is broken down into subseries related to agriculture, bills and propositions, and miscellaneous. The series also contains legislative books describing assembly people, legislature, and legislative acts.

The **Newspaper clippings and articles** (1942-1986) contains various newspapers covering George Zenovich during his time as an Assemblyman, Senator, and lobbyist. Some also reference his hobby as a musician and events he participated in such as bringing squirrels back to Sacramento. There are five scrapbooks that have articles that track Zenovich's political career. There are magazine articles as well written by and about him.

The **Personal** series (1960-1992) consists of correspondence between him, family, and friends. There are also papers that show his personal preferences and active duty as president of his church.

The **Press releases** series (1967-1978) are sectioned into indexed and unindexed. This series has various press releases that cover important political issues, events, and legislation.

The **Multimedia** series (1976-1977) contains audio recordings that cover farm labor and Proposition 14. There is also one unidentified VHS tape.

The **Photographs** series (1962-1979) consists mostly of framed photographs from throughout Zenovich's political career. The series details his works and speeches with famous political figures such as John F. Kennedy, Robert Kennedy, Governor Jerry Brown, and Cesar Chavez. There are also loose photographs showing Zenovich's senate campaign.

The **Artifacts** series (1975-1984) include campaign stickers, a plaque, a license plate, a matchbook, and a plastic beer bottle cap.
